Communications

 Principal Report – Brenda Congo: Planning a celebration for staff Friday, 2-25-22 for the earlier enrollment of 300 students and, presently, 400 students enrolled along with 26 staff members. Dates have been established for summer school which is open for surrounding schools. Graduation Date (Board invited) June 17, 2022 @ 5pm. Ordering more Chromebooks and staff laptops as well. Working on Grad Nite plans and staff will be present at the Adelanto Expo on March 25. Two student governments also created.

- Financial Board Report with check detail Zach Wolfe: cash through January has risen to about 1.2 million dollars which will help with enrollment growth. Revenues have no issues – trying to be strategic with federal dollars. Cash is no issue. Expenditures: working on hiring new certificated teachers.
- 3. Supplement to the LCAP Presentation Brenda Congo/CBO: Mid-year review required by state. Taylion's LCAP Goals focus on Student Achievement, Comprehensive PD, and Educational Partners. Recap given on ESSER expenditures and other funding as applied to Taylion's goals. Overview provided on safety for all students and staff.
- 4. A-G Grant Public Hearing Zach Wolfe: Funding allocation requiring two board meetings to present grant (tonight) plus a second one for approval. The school can expense dollars on struggling students and their support systems. This is a grant trying to provide additional resources to unduplicated students. Board suggestions: possible community involvement, additional devices & hotspots, parent communication on college opportunities. Topic of foster students' needs and ways to utilize this grant education for foster parents, social workers, and college prep.
- 5. Next Regular Board Meeting Date March 24, 2022, at 6:00pm. This may be canceled if there are no agenda items requiring approval or rescheduled if needed. Special meetings may be scheduled as needed.
