Principal Report - Brenda Congo: Principal updated enrollment of 419 students, 4 teachers w/single subject, 4 teachers w/multiple subject, 6 teachers w/CTE, 2 SPED teachers, 3 personnel credentials, with 12.5 SSCs, 3 tutors/instructional assistants - all with a goal as to support our students. On March 26th, THDA participates in the Victorville Family EXPO – event from 10am to 5pm with full staff attendance. THDA is continuing to work with Goodwill and Desert Mtn. SELPA, as well as Adelanto Elementary. State testing will be kicking off after Spring Break. 150 new Chromebooks have been ordered for distribution. Graduation set for June 17th. Safe Return to Instruction Plan has been created and posted to the website. Additionally, the 2022 -23

school calendar has been shared – all three tracks have been condensed into one calendar rather than three separate. A vote of approval will take place at the April board meeting. Shannon Smith added that she is excited to attend the Expo and will bring the Taylion shirts with her.
